## Rules and Regulations For Exhibitors

### **Move-In and Set-up**

-Exhibitor spaces will be available for set-up from 8am until 6pm on Thursday, July 15th, 2021. Move-in hours will be strictly enforced for security purposes. **ALL EXHIBITORS MUST BE SET UP PRIOR TO 6PM, THURSDAY, JULY 16TH. NO EXHIBITORS WILL BE ALLOWED TO SET UP AFTER 6PM, THURSDAY. NO EXCEPTIONS!**

-Parking/gate passes and exhibitor credentials will be issued at the exhibit registration building located inside Gate 7. Registration will be manned Thursday, July 15th, 2021 from 8am until 6pm. **Each exhibitor will be issued one (1) on grounds parking pass (THESE VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY)**

**-Vendor Gate Passes: 2 passes are included with your vendor space;**

**Additional vendor passes may be purchased for \$35 each for a weekend pass and \$15 each for a single day pass.**

-Indoor exhibitor fee covers space as well as electric, pipe and drape. On-site contracted exhibitor decoration services will be provided by **Northeast Decorating & Exhibit Services, Inc., P.O. Box 607, Syracuse, NY 13209**. A list of optional services and fees offered by this contractor can be obtained by calling **(315) 471-9989**.

-Exhibitors requiring more than basic electrical service will be charged a fee. Please contact Syracuse Nationals staff at **(800) 753-3978** as early as possible if a need for such services is anticipated.

**-Exhibitor display and merchandise must remain within the confines of the contracted space. Exhibit materials must not overflow into the aisles. Distribution of literature and sales aids must take place within the assigned space ONLY.**

-Booth space must be used solely by the company/person and for the products and services stipulated by the rental agreement. Subletting of space by exhibitors is strictly prohibited and will result in immediate eviction without refund.

-Exhibitors are required to maintain a neat and orderly appearance at all times. Right Coast reserves the right to remove and vendor not selling items described on the front of this application, or deemed not family friendly by Right Coast, Inc. staff. All decisions are at the sole discretion of Right Coast, Inc., and final. **NO REFUNDS.**

### **Exhibit Hours**

-Exhibit hours are 9am - 6pm on Friday & Saturday and 9am - 3pm on Sunday.

### **Breakdown and Move-Out**

**Exhibitors will be required to remain open and operational until 3pm Sunday.**

Move-out of buildings must be completed no later than 7pm on Sunday. All trailers and outside displays must be removed no later than 5pm on Monday, July 19th, 2021. **In order to protect spectators, display vehicles cannot be moved or started until the show closes each day.**

(Sunday closing and/or tear down before 3pm will forfeit first right of refusal for 2022 space selection.)

Vendor trailers will not be allowed on show grounds until 3pm Sunday.
