Rules and Regulations For Exhibitors

Move-In and Set-up Indoor/Outdoor Vendors

Exhibitor spaces will be available for set-up from 8am until 8pm on Wednesday & Thursday, July 15 and 16. Move-in hours will be strictly enforced for security purposes.

ALL EXHIBITORS MUST BE SET UP PRIOR TO 8PM, THURSDAY, JULY 16TH. NO EXCEPTIONS! *Special arrangements for early arrival can be made by calling the Right Coast office at 800-753-3978.

Indoor exhibitor fee includes space as well as pipe, drape and 110v electricity. On-site contracted exhibitor decoration services will be provided by Northeast Decorating & Exhibit Services, Inc., P.O. Box 607, Syracuse, NY 13209. A list of additional (optional) services and fees offered by this contractor can be obtained by calling (315) 471-9989.

Exhibitors requiring more than basic 110v electrical service will be charged a fee of \$150. Please contact Right Coast staff at (800) 753-3978 as early as possible if a need for such services is anticipated.

Exhibitor display and merchandise must remain within the confines of the contracted space. Exhibitor materials must not overflow into the aisles. Distribution of literature and sales aids must take place within your assigned vendor space ONLY.

Booth space must be used solely by the company/person and for the products and services stipulated in the rental agreement. Subletting of space by exhibitors is strictly prohibited. FOOD & BEVERAGE sales will NOT be permitted. Any violation of contracted services will result in immediate removal without refund.

*All food/beverage/concession sales must be contracted through the New York State Fairgrounds (315) 487-7711.

Exhibitors are always required to maintain a neat and orderly appearance. Right Coast reserves the right to remove any vendor not selling items listed on this application or deemed not family-/show friendly by Right Coast, Inc. staff. All decisions are at the sole discretion of Right Coast, Inc., and final. NO REFUNDS.

Credentials

Parking/gate passes, and exhibitor credentials will be issued at the exhibit registration building located inside Gate 7. Registration will be open Wednesday & Thursday, July 15 & 16 from 8am until 8pm. Each exhibitor will be issued one (1) on grounds parking pass (THESE VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY. PLEASE NOTE: Non-Display vehicles will not be allowed to park in or around display areas.)

Misuse of credentials will result in immediate ejection from the event without refund.

Vendor Passes

Vendor Passes as issued as follows: (2 weekend passes – 10x10 and 10x20 space) (4 weekend passes – 10x30 space and larger) Additional weekend vendor passes may be purchased for \$25 each at the registration desk located at Gate 7.

Exhibit Hours

Indoor exhibit hours are 9am - 6pm on Friday & Saturday and 9am - 3pm on Sunday.

Outdoor exhibit hours are 8am - 6pm on Friday & Saturday and 8am - 3pm on Sunday. Outdoor exhibitors desiring to remain open after 6pm on Friday & Saturday are encouraged to do so.

Breakdown and Move-Out

Exhibitors will be required to remain open and operational until 6pm Friday and Saturday, and 3pm Sunday.

(Sunday closing and/or tear down before 3pm will forfeit first right of refusal for 2021 space selection and risk application rejection)

Move-out of buildings must be completed no later than 9pm on Sunday. All trailers and outside displays must be removed no later than 5pm on Monday, July 20th, 2020. In order to protect spectators, display vehicles cannot be moved or started until the show closes each day.

Refunds

Refunds will be issued for cancellations made on or before June 30, 2020.

General Insurance Liability

Right Coast, Inc., its agents, representatives, sponsors or employees are not responsible for any injury, loss or damage that may occur to the exhibitor or the exhibitor's employees or property from any cause or condition.

Compliance & Enforcement

Right Coast Inc reserves the absolute right to remove any and all persons at its sole discretion without refund.

Security

Security is provided for the venue only. All participants are responsible for their own property (ie., vehicles, personal belongings, merchandise etc.) The security office is located at Gate 2.

Noise Restrictions

Radios, stereos, TV's loudspeakers etc., shall not be operated in such a manner as to disturb others.

Single Occupant Scooters

Personal handicap mobility scooters may be used at the event.

Golf Carts

Personal Golf Carts are approved for use in the campgrounds only. Any personal Golf Carts found in use during show hours will result in ejection from the event without refund. All golf Carts must have permits.

Right to Reject Application for Space Rental or Renewal

Right Coast Inc reserves the right to reject any application for space rental or renewal on the basis of unsatisfactory previous conduct, sales of merchandise that does not fit within the scope of the event or is in direct conflict with the rules and regulations outlined in this contract, or upon any other basis made in the sole discretion of Right Coast Inc., Right Coast Inc. reserves the right to remove individual who exhibit unsatisfactory behavior during the event without refund.
